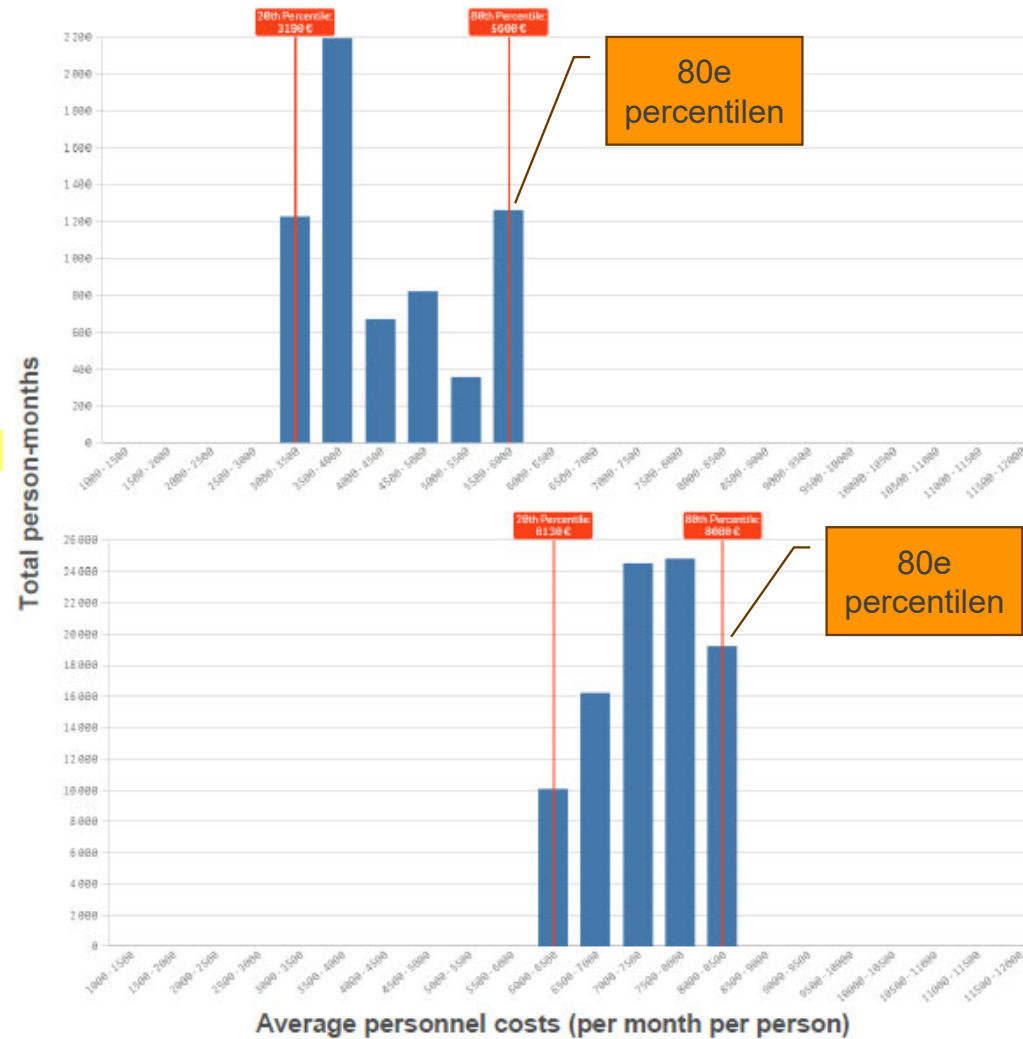

# Horizon dashboard for lump sum evaluations

- Latest version released on 19 June 2023, following intensive discussions with NCPs and the Programme Committee.
- Based on grants signed from 2021.
- Experts are briefed that the dashboard provides an **orientation**, no automatic cuts. Need for senior staff and inflation are mentioned as possible reasons for higher costs.
- Applicants are expected to **justify high personnel costs** (e.g., in the 'Any comments' tab of the detailed budget table).



# Prefinancing may be offset

Prefinancing payments (or parts of them) **may be offset** (without the beneficiaries' consent) against amounts **owed by a beneficiary** to the granting authority — up to the amount due to that beneficiary.

For grants where the granting authority is the European Commission or an EU executive agency, offsetting may also be done against amounts owed to other Commission services or executive agencies.
